**GLOUCESTER COUNTY INSURANCE COMMISSION
RESOLUTION OF AUTHORITY FOR SETTLEMENT WITH
PETITIONER, ANTHONY IZZO, JR.**

WHEREAS, Anthony Izzo, Jr., a corrections officer, sustained a work related injury involving a motor vehicle accident on or about July 14, 2010, resulting in the following injuries: C2-3 bulging, C3-4 bulging with impingement on the thecal sac, L1-2 bulging, mild retrolisthesis of L5 on S1 with annular bulging, right sided herniation at C3-4, degenerative disc disease (pre-existing, but exacerbated), mild left C4 radiculopathy with some evidence of active process in addition to median neuropathy (hereinafter "incident" or "the incident"), and;

WHEREAS, the incident subsequently resulted in the filing of a workers' compensation claim styled as Anthony Izzo, Jr. v. Gloucester County in the Workers' Compensation Court, Claim Petition No. 2010-18727 (hereafter "action" or "the action"), and;

WHEREAS, the aforementioned claim and action so filed have now been resolved, and;

WHEREAS, a "SETTLEMENT" (hereinafter "Settlement") has been negotiated and agreed upon between the Petitioner, Anthony Izzo, Jr. (hereinafter "Petitioner" and/or "the Petitioner") and the County of Gloucester, totaling **\$2,990.00**, and;

WHEREAS, the Petitioner chose to waive the right to an award for permanency in exchange for an Order for Continuing Medical Treatment relative to the neck injury; and

WHEREAS, the Settlement is not intended, nor should it be intended to be an admission of any liability wrongdoing, or impropriety by the parties, and;

WHEREAS, the Settlement has been evaluated by defense counsel for the Gloucester County Insurance Commission, and;

WHEREAS, the Gloucester County Insurance Commission believes that it is in its' best interests to enter into the Settlement with Petitioner so as to ensure that all matters set forth in and involving the claim and action are forever resolved,

Now therefore

BE IT RESOLVED, by the Gloucester County Insurance Commission that disposition of the claim filed by the above referenced individual is authorized as follows:
