

**RESOLUTION 46-14**

**GLOUCESTER COUNTY INSURANCE COMMISSION  
RESOLUTION OF AUTHORITY FOR SETTLEMENT WITH  
PLAINTIFF, ESTATE OF PATRICK GEORGETTE**

**WHEREAS**, the Estate of Patrick Georgette (hereinafter "Plaintiff"), has filed a lawsuit in the Superior Court of New Jersey, Law Division, Gloucester County, Docket Number L-843-13 and styled as the Estate of Patrick Georgette v. Gloucester County, Commission Case Number 3530000494 (hereafter "action" or "the action");

**WHEREAS**, the aforementioned action filed has now been resolved, and;

**WHEREAS**, a SETTLEMENT (hereinafter "Settlement") has been negotiated and agreed upon between Plaintiff and the County of Gloucester as follows;

- Payment in the amount of \$82,500 to the Estate of Patrick Georgette;
- Payment in the amount of \$37,500 in attorney fees to the Law Firm of Ionno and Higbee; and
- Payment of Decedent's outstanding medical expenses for treatment received 9/15/11 and 9/16/11 in the amount of \$3,096.22

**WHEREAS**, the Settlement is not intended, nor should it be intended to be an admission of any liability, wrongdoing, or impropriety by the parties, and;

**WHEREAS**, the Settlement has been evaluated by defense counsel for the Gloucester County Insurance Commission, and;

**WHEREAS**, the Gloucester County Insurance Commission believes that it is in its' best interests to enter into the Settlement with Plaintiff so as to ensure that all matters set forth in and involving the matter and action are forever resolved,

**NOW THEREFORE BE IT RESOLVED**, by the Gloucester County Insurance Commission that disposition of the claim filed by the above-referenced estate is authorized as follows:
