



**CERTIFICATE OF INSURANCE REPORT:** Executive Director reported on the Certificate of Insurance Report for the period of 2/23/13 to 3/21/13. There were a total of 20 certificates issued for this period.

**GCIC PROPERTY AND CASUALTY FINANCIAL FAST TRACK:** Executive Director advised the January Property & Casualty Financial Fast Track was included in the agenda. The Commission had a surplus of \$1,383,804 as of January 31, 2013. Executive Director advised that \$653,297 on line 7 of the report "Investment in Joint Venture was the GCIC's share of the CEL JIF equity and was part of the GCIC surplus.

**NJ CEL PROPERTY AND CASUALTY FINANCIAL FAST TRACK:** Executive Director reported the agenda included the January Financial Fast Track for the NJ CEL. As of January 31, 2013 the CEL had a surplus of **\$2,335.188.** 

**HEALTH BENEFITS FINANCIAL FAST TRACK**: Executive Director advised the Health Benefit Financial Fast Track was included in the agenda. The Insurance Commission had a Health Benefit surplus of \$125,575 as of January 31, 2013.

**NJ EXCESS COUNTIES INSURANCE FUND (CELJIF):** Executive Director reported the CEL met on February 28, 2013. A summary of the report was included in the agenda. Executive Director advised the CEL re-organized and Commissioner Smith of the Burlington County Insurance Commission was appointed as the Chairman and Commissioner MeCouch of the Cumberland County Insurance Commission was appointed as secretary. Executive Director also reported, Mr. Nolan, the CEL Underwriting Manager, attended the meeting and provided an update on the marketing efforts to replace the Meadowbrook program. Executive Director indicated the objective was to present the CEL with options at the April meeting.

**EMPLOYEE BENEFITS:** Executive Director reported Ms. Brown could not attend the meeting but he would review her report with the Commissioners. Executive Director advised a RX rebate check was received and sent to the County in the amount of \$9,551.88. This check represented rebates for RX utilization by the County for the third quarter of 2012. Executive Director then referred to the Client Activity Summary Report which was included in the agenda for the period of 2/1/13 to 2/28/13. Executive Director noted the number of calls for February was 99 which were down from the 182 calls received in January. Ms. Rick reported CSG was attempting to recruit some of the medical providers that were in First Managed Care Networks which the Insurance Commission had favorable results in treating injured employees. Ms. Rick indicated it was their recommendation the Safety Department staff try to utilize three of facilities on the list. Ms. Rick explained this would ensure better results and allows CSG to negotiate discounts.

The form would include additional questions for the injured worker to answer. The revised form would aid the medical providers in identifying injuries caused by employment versus pre-existing conditions. Ms. Rick explained once the Commission adopted the Resolution, it could be submitted to the County Freeholders and request they adopt the Resolution. Once the process was completed the form would be used for all GCIC workers' compensation claims.

Ms. Rick provided an update on the Hurricane Sandy Claims. Ms. Rick advised FEMA recently issued a check to the GCIA for their rain cover. Under the Commission's Risk Management Plan, Inservco would reimburse the GCIA for the insurable portion of the windstorm claim not paid by FEMA.

Ms. Rick advised she had 2 action items for coverages that could not be placed through the GCIC/NJCEJIF or its master programs.

Ms. Rick reported the Gloucester County 4H Association's Crime policy was renewing on 4/14/13. Ms. Rick was able to obtain a quote from Selective Insurance Company which would reduce the premium to \$250 annually/\$750 for three years.
